**8 ITEMS FOR DISCUSSION**

- 8.1 Co-opting Ian Rigby was co-opted This was proposed by Cllr A Jackson and seconded by Cllr T Boulton. Documents handed out. Acceptance of office was signed. Register of Interest form completed and sent to SBC.
- 8.2 Parking opposite Witching Post It had been brought to the attention of the council that the verge opposite the Witching Post is being dug up by vehicles. A letter is to be sent to nearby local businesses and residents to ask if they can assist in deterring people from parking on the verges. Cllr A Jackson to compile and send letters.
- 8.3 YLCA Your council representatives There was no volunteers at this time
- 8.4 Cleaners Contract and Scope of work was reviewed and accepted  
Cllr A Jackson is to take the new contract and scope of work to C Dowson for signature
- 8.5 Budget The council reviewed the budget and are to continue to monitor
- 8.6 Sponsor a Seat J Hallam Joinery have agreed to sponsor a seat and the clerk will order a plaque. The Postgate have also agreed to continue sponsoring a seat. Cllr A Jackson to collect funds. There is a seat vacant and Cllr A Jackson is looking into a possible sponsor.
- 8.7 Amount for Egton Field Show to be reviewed. F Lees have asked that the amount of rent for the Monument field be reduced. Lees had said they would email their comments and the council agreed to review this upon receipt of the email.
- 8.8 Renting of Monument field Letter received from S Cornforth relinquishing agreement for Monument Field received and noted.
- 8.9 Fields in Trust Clerk to try and organise Fields in Trust to come to do a Presentation to councillors, residents and interested parties..
- 8.10 Village Improvement Scheme It was noted that the grant had been accepted for the refurbishment of the stone block, originally part of the Egton Village well structure and that work may start around December.

There had been no update on the painting of the toilets and the clerk is to ask L Fletcher to contact Cllr S Harrison with regards to this.
