## **North Yorkshire Council/Highways**

a. Local housing including potential playpark

b. Sunken manhole near railway crossing

RESOLVED – Highways have confirmed they will not be repairing as the manhole is not low enough. Remove from the agenda.

c. River Esk Bridge – full repairs planned for the Spring

TO NOTE – works remain outstanding.

d. Graystone – drain outside property

TO NOTE – Highways have confirmed this is Yorkshire Waters manhole and they have reported.

e. Low Fairhead to Fairhead – grit heaps

TO NOTE – clerk to obtain quotes for 3 piles of grit from Low Fairhead to Fairhead.

f. Parking arrangements for events

TO NOTE – complaints had been received about the inconsiderate parking during the Flying Scotsman's visit and lack of parking arrangements in place. The clerk was asked to contact North Yorkshire Council's event management team to ask if risk assessments were carried out and following this write to North York Moors Railways with their future plans when events are held, also include large coaches coming into the village and access.

It was also agreed that should we have a problem with a defibrillator in the interim, if an insurance claim was to go ahead in the event of a problem they can be hired on a pay-as-you-go plan from £1 a day and this would be an option we would proceed with so the village was not without a defibrillator.
