### Follow up to matters arising:

#### Casual Vacancy

The proposed candidate for the vacancy on the Parish Council has agreed to accept the role. The welcome information has been forwarded.

#### Highways Site Meeting and VAS signs

A site meeting with Highways and Police was held on the 17<sup>th</sup> November 2022.

More details of the approved VAS devices were requested. These are:

The VAS signs should last 10+ years and can be purchased with a 5 year or 10 year warranty.

Once purchased they do not need recalibrating.

They are lightweight and portable so could be transferred between communities and trained volunteers could carry out the relocation.

The signs must be the speed limit reminder type and not a speed indicator device. Smiley/sad faces are not permitted.
