

## Clerk's report following 20<sup>th</sup> July 2021 meeting

### Follow up to matters arising:

#### Electrical Connection

A quote has been received for the installation of the meter and electrical connections at the village green. Work will not be able to be started until the end of August.

A request for replacement of the Church Street sub-station gates has been submitted to Northern Powergrid. Confirmation of receipt has been received and the request has been forwarded to their wayleave department.

#### Section 19 Report

An update on the feasibility study was requested from the NYCC Flood Management team. The following notice has been received:

The feasibility study has recently been returned to us by WSP and we are now conducting final checks of the document. Once these are complete we will present the document back to the Parish Council.

Metcalfe Farms and the MOD have been notified.

#### Memorial Bench

Confirmation of the order has been received and the family have approved the design for the memorial plaque. Delivery is due at the end of August.

#### External Audit

A number of queries were received from PFK Littlejohn relating to the 2019/2020 data. The additional information has been submitted.

A data audit of the governance documentation held has been undertaken based on the YLCA template.

#### Street Lighting

The application for additional street lighting on Moor Road and the Olde Wynd has been submitted to Richmondshire District Council.

#### Highways

The gullies on Moor Road were reported to highways and the following has been received:

The Highway Officer advises me that he had raised an order to have the gullies on Moor Road cleaned and jetted. I am pleased to inform you that this work was completed on the 27<sup>th</sup> July.

An update on the design planning stage for the Bellerby to Leyburn footpath has again been requested.

#### COMMUNITREE Tree Planting Project

RDC are seeking support from Parish Councils for a tree planting project:

You will be aware of the Communitree project that Valerie Adams, RDC Climate Change Officer, and I have been promoting on behalf of the Richmondshire Climate Action Partnership and the District Council.

The aim is to encourage each Parish across the District to Plant up to 30 trees in publicly accessible places next winter. The trees and shelters will be provided free to Parishes together with any necessary assistance on trees, sites etc.

This is, of course, only a small action in the fight against Climate Change which has been made even more urgent by the recent IPCC report but would be a valuable contribution by the local community. I appreciate that
