
## **Defibrillator**

The Clerk & Chairman attended the Highways workshop at Area 1 Gatherley Road. The question of closing the road to prevent vehicles entering the village during a flood event was raised and the advice was to not attempt to close the road but inform the emergency services.

The issue of gritting the side roads of Bellerby was raised and the following follow up response received:

I am just emailing at this point to let you know that I have raised this at a Senior level with the County Winter Champion and the Head of Service. Unfortunately it may take some time to look at the potential wider implications of your request and due to current demand for service I can't provide a potential timescale for a decision. Ultimately this may lead to the development of a new policy as it is not a request we have dealt with historically and part of that process will be to engage with the Councils Legal and Insurance Teams to see what their thoughts are for the protection of all parties.

Please bear with us for now I will keep you informed as and when I know more.


The posts for the VAS sign have been installed.
