# **Banking**

### 20mph Speed Limit Moor Road and Church Street

The following response was received:

Just to confirm that the only thing that has been agreed at the present time is for us to move forward with the consultation and advertising stages necessary to create a Traffic Regulation Order to allow the introduction of the 20 Mph Speed Limit. As you will be aware this process involves the distribution of details of the proposal to various local and national organisations (including the Parish Council) and to local residents and then the public advertisement of the details both on site and in the local press. At each stage comments are invited and if any objections are received which cannot be addressed then a report would need to be made to an appropriate Council committee in order that Members could resolve the way forward.

In addition to the above I would add that should the proposal achieve consent following the above process then I understand that it will then need to be added to a County wide list of similar schemes awaiting funding.

Going back to the consultation stage outlined above, just to confirm that I would hope to get the documents distributed before the end of the month (November).

### Defibrillator

The routine check of the Memorial Hall defibrillator has been completed and the system updated accordingly.

The Cross Keys defibrillator has been checked following its deployment and the system updated accordingly.

### **Highways**

The gully at Myrtle House has again been reported. The response received:

The HO has inspected this gully again. It is showing no signs of being blocked. Possibly a slow drainer

The VAS agreement has been signed and submitted. The countersigned agreement has been returned and the VAS has been ordered. The posts and sign will be installed in a few weeks' time.

The following response was received from the Area Manager re gritting in Bellerby:

Unfortunately as you say Church Street and Moor road do not fit the existing Community Gritting Partnership as it is for footway treatments. I am afraid that on this occasion we are unable to assist you further, Church Street and Moor Road will be treated in line wit the Winter Maintenance policy for priority 3 routes.
